What is this product?

Type: This is a closed-ended investment company incorporated in England and Wales, listed on the London Stock Exchange with effect from 23 November 2021. The Company has an unlimited life and there is no maturity date for the ordinary shares. There is no recommended holding period for the ordinary shares (although a holding period of 5 years has been used for the purposes of the calculations in this document). The return from an investment in the ordinary shares will be driven by the price at which the ordinary shares are sold compared to the original purchase price, and by any dividends paid by the Company to the investors in its ordinary shares during the holding period. The price at which an investor may dispose of ordinary shares will depend on the prevailing secondary market price, which may, or may not, reflect the prevailing net asset value per ordinary share.

Investment Objective: The Company's investment objective is to: support the net zero agenda whilst delivering capital growth and progressive dividend income to its shareholders; integrate ESG best practice with a focus on investing in new renewable energy capacity and onsite clean energy solutions; and target long-term secure income with limited exposure to wholesale power prices.

The Company will seek to achieve this by investing in private wire solar PV generation systems and associated infrastructure (Onsite Solar Assets.) Each such system will be commercialised through one or more power purchase agreements and/or other revenue agreements associated with the system with a contract counterparty. The Company may also make investments in solar photovoltaic generation systems and associated infrastructure which are not located on the site of a contract counterparty (Long-Term Grid Assets).

Intended Retail Investor: An investment in the Company is intended for institutional investors and professionally-advised or knowledgeable retail investors. It is suitable for investors who are capable of evaluating the risks and merits of such an investment and who have sufficient resources to bear the economic risk of a substantial or entire loss of their investment and who can accept that there may be limited liquidity in the shares.

Maturity Date: The Company has an unlimited life and there is no maturity date for the ordinary shares.

The summary risk indicator is a guide to the level of risk of the Product compared to other products. It shows how likely it is that the Product will lose money because of movements in the market or because we are not able to pay you. We have classified this Product as 4 out of 7, which is a medium risk class. This rates the potential losses from future performance at a medium level, and poor market conditions could impact our capacity to pay you. This Product does not include any protection from future market performance so you could lose some or all of your investment. If we are not able to pay what is owed, you could lose your entire investment.

Performance Information

The main factors that will affect the performance of the Company are the manager's ability to manage the credit risk of Contract Counterparties; the performance of the underlying PV solar assets; the cost of finance; the conditions in the Global energy markets and power prices in the UK electricity markets.

Our forward-looking moderate performance scenario is an annualised return of 8.8% over the recommended holding period of five years. We have used this return in our reduction in yield calculations below.

As the Company is relatively young, we backfilled the Company's returns with proxies to give daily performance dating back to 29 May 2013. We have used this to provide objective evidence for the longer-term performance characteristics of the Company. The average risk¹ of the proxy over a rolling five-year window was 9.9%, however, periods of stress in the energy markets, the one-year volatility of the proxy temporarily increased to 24.3%.

What could affect my return positively?

Specific factors that affect returns positively would be good environmental conditions for the PV solar assets and the Manager's ability to originate new projects at attractive valuations as well as add value through its installation strategy. Improvements in the valuation of the solar energy stocks is also likely to positively impact returns. Over the recommended holding period of five-years, a favourable rolling five-year performance of the proxy was 11.9% per annum.

What could affect my return negatively?

Specific factors that affect returns negatively would be an increase in the cost of finance which could restrict access to financing on favourable terms. An increasing cost of finance could also affect the discount rates used to price the underlying assets causing them to decrease in value. A fall in the valuation in solar energy stocks is also likely to negatively impact returns. The proxy had a least favourable five-year rolling return of -2.2% per annum.

What could happen in severely adverse market conditions?

The markets are currently experiencing adverse conditions, and the Company has experienced a loss of 35.2% between Jan 2022 and Sep 2023. Under severely adverse market conditions, there is a risk that the capital value of an investment in the Company's shares could reduce significantly, potentially down to zero.

What happens if Atrato Onsite Energy plc is unable to pay out?

The Company is not required to make any payment to you in respect of your investment. If the Company were liquidated, you would be entitled to receive a distribution equal to your share of the Company's assets, after payment of all of its creditors. There is no compensation or guarantee scheme in place that applies to the Company and, if you invest in the Company, you should be prepared to assume the risk that you could lose all of your investment.

¹ Risk is the annualised standard deviation of daily returns.

Composition of costs
